WHEREAS, on November 21, 2014 a fire razed the houses of One Hundred Fifty Three (153) families at Homart, Barangay Baesa, Quezon City;

WHEREAS, included in the 153 families affected are the Eighty Seven (87) homeowners, Forty Six (46) renters and Twenty (20) sharers;

WHEREAS, a financial assistance from the City Government will help alleviate the unfortunate conditions of the affected families.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the One Hundred Fifty Three (153) families affected by a fire that occurred on November 21, 2014 at Homart, Barangay Baesa, Quezon City, at Two Thousand Pesos (P2,000.00) per family owner, and One Thousand Five Hundred Pesos (P1,500.00) per family renter and sharer.

RESOLVED, FURTHER, that the funds for this purpose shall be taken from the appropriations for Grants, Aids and Subsidies under the Office of the City Mayor in the 2015 Annual Budget of Quezon City.

RESOLVED, FINALLY, that the Social Services and Development Department, in coordination with the Sangguniang Barangay of Barangay Baesa, shall facilitate the grant of the financial assistance.
