WHEREAS, she was the Representative of the 1st District of Iloilo;

WHEREAS, she graduated cum laude with a degree of Bachelor of Science in Medical Technology at the Divine Word University in Tacloban City, and she was an academic scholar at the St. Luke's College of Medicine, and she also had two years of residency training in Obstetrics and Gynecology at the Iloilo Doctor's Hospital;

WHEREAS, she was elected as the first Filipino board member to the Parliamentary Network on the World Bank (PNoWB) during its Sixth Annual Conference held in Helsinki, Finland, and she was re-elected to this post to the following conference in Paris, and she has also represented the Philippines in various conferences conducted by the Asian Forum of Parliamentarians on Population and Development (AFPPD);

WHEREAS, President Benigno Aquino III finally appointed Hon. Janette Garin as Secretary of the Department of Health (DOH) last March 12, 2015.
