A RESOLUTION AUTHORIZING THE QUEZON CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (I) UNIT OF MOTOR VEHICLE IN THE AMOUNT OF FOUR MILLION ONE HUNDRED FOURTEEN THOUSAND TWO HUNDRED PESOS (PHP4,114,200.00), INTENDED FOR THE USE OF THE QUEZON CITY COUNCIL TO BE CHARGED AGAINST THE FUNDS OF THE INTERNAL ACCOUNTS OF FICE.

Introduced by Councilors JESUS MANUEL C. SUNTAY and GODOFREDO T. LIBAN II.

WHEREAS, under Section 2, Article I of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, it is the policy of the State to promote the ideals of good governance in all its branches, departments, agencies, subdivisions and instrumentalities including government-owned and controlled corporations and local government units;

WHEREAS, to ensure that the functions of the City Council be fully performed, there is an imperative need to provide the Quezon City Council a necessary motor vehicle;

WHEREAS, the Office of Councilor Jesus Manuel C. Suntay desires to procure one (1) unit of 30 Seater COASTER to be used for the aforesaid purposes, with the following general specifications:

 ENGINE MAKE/MODEL: 4.1 Liter, 4 Cylinder in-line, OHV 16-Valve, Gear Drive Diesel, 134 HP / 3,000 RPM Maximum Output and a Torque of 360 NM / 16,000 RPM 5-Speed Manual Transmission

Bautista, to purchase one (1) unit of motor vehicle in the amount of Four Million One Hundred Fourteen Thousand Two Hundred Pesos (Php4,114,200.00), intended for the use of the City Council, to be charged against the funds of the Internal Accounts Office.
