BAUTISTA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE TEACH FOR THE PHILIPPINES INC., (TFP) AND THE DEPARTMENT OF EDUCATION, DIVISION OF CITY SCHOOLS, QUEZON CITY, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, Teach For the Philippines (TFP) works to provide all Filipino children with inclusive, relevant, and excellent education. TFP enlists some of the country's most promising young leaders to teach for two years in public schools throughout the Philippines. Through their experiences in the classroom, Teach for the Philippines transforms our leaders into lifelong advocates for education equity;

WHEREAS, TFP is focused on bridging the education gap in the Philippines by advocating functional literacy and progressive teacher and administrator training. The pilot initiative is designed to recruit, select, train and provide on-going professional development to young individuals committed to closing the achievement gap by serving as Fellows in under-resourced school systems;

WHEREAS, the TFP, in the accomplishment of its mission, needs the support of the various sectors of society to include other agencies, government officials, and local government units;

WHEREAS, it is a necessity that a Memorandum of Agreement be executed and entered into by and between the local government of Quezon City, through Mayor Herbert M. Bautista, the Department of Education, Division of Quezon City, through Dr. Helen Grace V. Go, Schools Division Superintendent - Officer-in-Charge, and the Teach for the Philippines through Margarita L. Delgado, CEO, to show that the parties have accepted and mutually agreed in the Terms and Conditions set forth under a Memorandum of Agreement.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to enter into and sign a Memorandum of Agreement with the Teach for the Philippines, Inc. and the Department of Education, Division of City Schools, Quezon City, subject to existing laws, rules and regulations.

RESOLVED, FURTHER, that a copy of this Resolution be furnished to the Department of Education, Division of City Schools, Quezon City through Dr. Helen Grace V. Go, Schools Division Superintendent—Officer-in-Charge, and the Teach for the Philippines through Margarita L. Delgado, CEO, for their information and guidance.

RESOLVED, FINALLY, to make the Memorandum of Agreement an integral part hereof.
