A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THIRTEEN (13) FAMILIES WHO WERE VICTIMS OF FIRE THAT OCCURRED LAST DECEMBER 4, 2014 AT KAPALARAN STREET, LITEX ROAD, BARANGAY COMMONWEALTH, QUEZON CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER TO BE TAKEN FROM THE APPROPRIATIONS FOR GRANTS, AIDS AND SUBSIDIES OF THE OFFICE OF THE CITY MAYOR, UNDER THE 2015 ANNUAL BUDGET, OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.

WHEREAS, on December 4, 2014, a fire occurred at Kapalaran Street, Litex Road, Barangay Commonwealth, Quezon City at about 1:00 AM. affecting thirteen (13) families;

WHEREAS, the City Government should extend financial assistance in order to alleviate the plight of said fire victims.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to thirteen (13) families who were victims of fire that occurred last December 4, 2014 at Kapalaran Street, Litex Road, Barangay Commonwealth, Quezon City, at Two Thousand Pesos (P2,000.00) each to house owners, and One Thousand Pesos (P1,000.00) each to renters/sharers, to be taken from the appropriations for Grants, Aids and Subsidies of the Office of the City Mayor under the 2015 Annual Budget of the Quezon City Government, or from any available funds of the City Government.

RESOLVED, FURTHER, that the Social Services and Development Department shall, in coordination with Sangguniang Barangay of Barangay Commonwealth, facilitate the granting of financial assistance to the said fire victims.
