A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO QUINSTONES CORPORATION FOR THE CONSTRUCTION OF A TWO (2)-STOREY OFFICE WAREHOUSE LOCATED AT LOT 31, BLOCK 105 SAN ANTONIO STREET, BARANGAY SAN ANTONIO, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception as provided for in Article IV, Article V, Article VI, Article VIII and Article IX, Section 18 of Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance, and its Implementing Rules and Regulations, to Quinstones Corporation, for the construction of a two (2)-storey office warehouse located at Lot 31, Block 105 San Antonio Street, Barangay San Antonio, Quezon City, allowing deviation from the restrictions of the Quezon City Comprehensive Zoning Ordinance No. SP-918, S-2000, as amended.
