A RESOLUTION URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO INSTALL CLOSED-CIRCUIT TELEVISION (CCTV) CAMERAS AND WATER LEVEL INDICATOR ALONG THE STRETCH OF TULLAHAN RIVER IN THE VICINITY OF DISTRICT 5 FOR FLOOD MONITORING AND FOR OTHER PURPOSES.

WHEREAS, from its inception up to the present, Close Circuit Television (CCTV) cameras has been found useful in assisting law enforcement authorities in their investigation and apprehension of criminals and criminal acts;

WHEREAS, the forecasting of floodwater situations is effectively managed and monitored through the use of CCTV by the Metro Manila Development Authority (MMDA), and is of great importance in determining whether or not a preemptive evacuation should be undertaken;

WHEREAS, Tullahan River, originating from La Mesa Dam, having an average width of 20.00 (m) in Quezon City traverses ten (10) Barangays of District 5 namely: Bagbag; San Bartolome; Gulod; Nagkaisang Nayon; Pasong Putik; Sta. Monica; Sta. Lucia; San Agustin; Novaliches Proper; and Fairview;

WHEREAS, during heavy downpour or continuous rainfall even without a typhoon signal, barangays alongside Tullahan River becomes prone to flooding;

WHEREAS, the existing warning procedure hardly meets the "Golden Hour" in timely evacuating the residents living in barangay adjacent or along Tullahan River to the designated evacuation centers.


WHEREAS, putting up CCTV cameras and water level indicator within the stretch of Tullahan River in the vicinity of District 5 will surely produce a real-time, reliable information and images on the water level situation of the river giving disaster and rescue teams a lead or enough time to move and conduct a preemptive evacuation for the safety of the affected residents.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Mayor, Honorable Herbert M. Bautista, to install Closed-Circuit Television (CCTV) Cameras and water level indicators along the stretch of Tullahan River, traversing District 5 for flood monitoring, and for other purposes.

RESOLVED, FURTHER, that copies of this resolution be forwarded to the Honorable Mayor Herbert M. Bautista and to all other concerned city departments for their information and appropriate action.


