A RESOLUTION RENEWING THE SPECIAL PERMIT GRANTED TO UNIPROM, INC. TO HOLD TWENTY (20) LOCAL AND INTERNATIONAL DERBIES AT THE SMART ARANETA COLISEUM FOR ONE (1) YEAR, SUBJECT TO THE EXISTING LAWS, ORDINANCES, RULES AND REGULATIONS, AND THE PAYMENT OF TAXES, FEES AND OTHER CHARGES.

WHEREAS, Uniprom, Inc. was granted a Special Permit to hold local and international derbies at the Araneta Coliseum as a cockpit by virtue of Resolution Numbers NC. 502, S-90 and SP-1475, S-2000;

WHEREAS, the renewal of the Special Permit granted to Uniprom, Inc., in Resolution No. SP- 5409, S-2012, Resolution No. SP- 5711, S-2013, and Resolution No. SP- 5872, S-2014, to hold the derbies will entail continued payment of taxes, fees, and other charges, to the City Government, aside from the attraction of tourists that the game may bring;

WHEREAS, there is a need to renew the said Special Permit to comply with the requirements of existing laws, ordinances and other issuances.
