RESOLUTION NO. SP- 6348 , S-2015

A RESOLUTION AUTHORIZING THE QUEZON CITY COUNCIL BOY SCOUTS OF THE PHILIPPINES (QCC-BSP) TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH ONE HUNDRED FORTY TWO (142) BARANGAYS IN QUEZON CITY, IN COMPLIANCE WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) CIRCULAR NO. 2008-85, URGING ALL LOCAL CHIEF EXECUTIVES TO SUPPORT THE BOY SCOUTS OF THE PHILIPPINES NEIGHBORHOOD SCOUTING PROGRAM AND ORGANIZING A SCOUT UNIT IN EVERY BARANGAY.
