A RESOLUTION STRONGLY SUPPORTING HOUSE BILL NO. 4606, ENTITLED "AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY PASONG TAMO, QUEZON CITY, TO BE KNOWN AS PASONG TAMO NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR".

WHEREAS, Section 1, Article XIV of the Philippine Constitution provides that "the State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all":

WHEREAS, Section 17, Article II of the Philippine Constitution further underscores that "the State shall give priority to education... to foster partriotism and nationalism, accelerate social progress, and promote total human liberation and development";

WHEREAS, consistent with the thrust of the National Government, the Local Government of Quezon City recognizes the importance, and gives priority to, public education, specifically public elementary and high schools, for the development of the City;

WHEREAS, there is no existing national high school in Barangay Pasong Tamo to cater to the 5,234 pupils of Pasong Tamo Elementary School;

WHEREAS, upon graduation, these students face geographic, logistical, and economic difficulties in continuing with secondary education;

WHEREAS, the recent enactment of Republic Act No. 10533, otherwise known as the "Enhanced Basic Education Act of 2013", will bring about several adjustments to be implemented by the year 2016;

WHEREAS, the Local Government of Quezon City deems it necessary to create more public high schools in the City, including Barangay Pasong Tamo, to be able to fulfill the constitutional mandate of providing access to basic education for the people.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to support, as it does hereby strongly support, House Bill No. 4606, entitled "An Act Establishing a National High School in Barangay Pasong Tamo, Quezon City, to be known as the Pasong Tamo National High School, and appropriating funds therefor".
