A RESOLUTION CONGRATULATING THE SANGGUNIANG BARANGAY AND RESIDENTS OF BARANGAY HOLY SPIRIT FOR BEING AWARDED AS THE CLEANEST, HEALTHIEST, AND THE BEST IN THE SOLID WASTE MANAGEMENT PRACTICE (CATEGORY-A) AMONG THE 1,706 BARANGAYS IN METRO MANILA IN THE RECENTLY HELD 2014 BARANGAY POWER CONDUCTED BY THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY (MMDA).

In fact, the said Barangay has the enviable distinction of having their own "Gulayan sa Barangay" where the waste materials derived from composting are used as fertilizer and the harvested vegetables contribute in the economic well-being of its marginalized residents;
