RESOLUTION NO. SP- 6360 ... S-2015

A RESOLUTION URGING THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) TO ISSUE AN IMPLEMENTING RULES AND REGULATIONS OR A STANDARD POLICY FOR THE AVAILMENT OF BENEFITS UNDER SECTION 393 OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991, SPECIFICALLY PARAGRAPH (B), SUB-PARAGRAPH (B) OF THE SAID CODE.

WHEREAS, Section 393 of Republic Act No. 7160, otherwise known as the Local Covernment Code of 1991, specifically Paragraph (b). Sub-Paragraph (3), provides that, "The Punong Barangay, the Sanggimiang Barangay Members, the Barangay Treasurer, and the Barangay Secretary shall also be entitled to free medical care including subsistence medicines, and medical attendance in any government hospital or institution: Provided, that such hospital care shall include surgery or surgical expenses, medicines, X-rays, laboratory fees, and other hospital expenses; In case of extreme urgency when there is no available government hospital or institution, the Barangay official concerned may submit himself for immediate medical attendance to the nearest private clinic, hospital or institution and the expenses not exceeding Five Thousand Pesos (P5,000.00) that may be incurred therein shall be chargeable against the funds of the barangay concerned;"

WideREAS, while there is a clear intent on the said provision to provide the Barangay officials with medical attention and needs, there are still many government hospitals or institutions that do not recognize the said provision or provide the benefits indicated therein.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULER SESSION ASSEMBLED, to urge, as it does hereby urge, the Department of the Interior and Local Government (DILG) to issue the Implementing Rules and Regulations or a standard policy for the availment of benefits under Section 393 of Republic Act. No. 7160, otherwise known as the Local Government Code of 1991, specifically Paragraph (b), Sub-Paragraph (3), of the said Code.
