RESOLUTION NO. SP- 6364 , S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT WITH MADDEL INTERNATIONAL PROPERTY LIMITED FOR THE PURCHASE OF ONE HUNDRED (100) UNITS OF POP-HUT EMERGÊNCY RESPONSE SHELTERS AND TWENTY (20) EXTENSION UNITS, IN THE TOTAL AMOUNT OF FOURTEEN MILLION SEVEN HUNDRED TWENTY THOUSAND PESOS (PHP14,720,000.00), TO BE USED IN CALAMITY AND DISASTER SITUATIONS AND IN THE DEVELOPMENT OF ON-SITE SOCIALIZED HOUSING PROJECTS.

WHEREAS, in time of calamities and disasters, such as floods, fires, typhoons and earthquakes, the Quezon City Government (LGU-QC) customarily utilizes schools, barangay halls, and other government facilities as evacuation centers or temporary shelters of its affected residents;

WHEREAS, the use of such government facilities, although temporary in nature, oftentimes disrupts the government's regular functions and services;

WHEREAS, MADDEL International Property Limited, an Australian company and exclusive manufacturer of Pop-Hut Emergency Response Shelters, has demonstrated and offered their product to the LGU-QC:

WHEREAS, the purchase of temporary shelters will certainly help the operations and implementation of the projects of the City Disaster Risk Reduction and Management Council (CDRRMC) and the Task Force on Socialized Housing and Development of Blighted Area (TF Housing);

WHEREAS, Pursuant to Section 455 (b) (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a contract with MADDEL International Property Limited, for the purchase of one hundred (100) units of Pop-Hut Emergency Response Shelters and twenty (20) extension units, in the total amount of Fourteen Million Seven Hundred Twenty Thousand Pesos (Php14,720,000.00), to be used in calamity and disaster situations and in the development of on-site socialized housing projects.

RESOLVED, FURTHER, that the Bids and Awards Committee and the Department of Engineering be furnished of this resolution.
