RESOLUTION NO. SP- 6372 , S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT/AGREEMENT WITH THE WINNING SUPPLIER BIDDER FOR THE PURCHASE OF MULTI-PURPOSE TENTS AMOUNTING TO TEN MILLION SEVEN HUNDRED EIGHT THOUSAND AND FIFTY PESOS (P10,708,050.00) TO BE DISTRIBUTED TO DIFFERENT BARANGAYS OF VARIOUS DISTRICTS OF QUEZON CITY.

WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, expressly provides that the City Mayor shall represent the city in all its business transactions and shall sign on its behalf, all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance;

WHEREAS, the Purchase Request amounting to Ten Million Seven Hundred Eight Thousand and Fifty Pesos (P10,708,050.00) was granted to the winning bidder for the purchase of multi-purpose tents to be distributed to different barangays of various districts of Quezon City;

WHEREAS, on February 25, 2015, a Memorandum was issued by the City Mayor directing all heads of departments, offices and operating units to observe the requirement that all purchase requests (PR) with an approved budget for the contract (ABC) amounting to P10 million and above must be accompanied by a resolution duly adopted by the City Council authorizing the Chief Executive to enter into such contract;

WHEREAS, pursuant to existing laws, rules and regulations, and in compliance with the February 25, 2015 Memorandum of the City Mayor requiring an authorization from the City Council for PRs with approved budget contract of P10 Million and above, this resolution is hereby made for said purpose.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Herbert M. Bautista, to enter into a contract agreement with the winning supplier/bidder for the purchase of multipurpose tents amounting to Ten Million Seven Hundred Eight Thousand and Fifty Pesos (P10,708,050.00) to be distributed to different barangays of various districts of Quezon City.
