A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT AGREEMENT WITH THE WINNING SUPPLIER BIDDERS FOR THE BASIC EDUCATIONAL BOOKS IN MATH AND SCIENCE AMOUNTING TO TEN MILLION FIVE HUNDRED THIRTY-TWO THOUSAND SEVEN HUNDRED FORTY-FIVE PESOS (P10,532,745.00), IN CONNECTION WITH THE BASIC EDUCATION ENHANCEMENT PROGRAM OF THIS CITY TO BE DISTRIBUTED TO DIFFERENT BARANGAYS IN DISTRICTS 1,2,3,4,5, AND 6 OF QUEZON CITY.

WHEREAS, Section 1, Article XIV of the 1987 Constitution mandates that the State shall promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all;

WHEREAS, the Quezon City government undertakes measures geared in improving the quality of basic education of our youth by providing and distributing books to Quezon City day-care pupils for free, thereby fulfilling the constitutional mandate to make quality education accessible to all;

WIIEREAS, Section 455 (b) (l) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, expressly provides that the City Mayor shall represent the city in all its business transactions and shall sign on its behalf, all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance;

WHEREAS, on February 25, 2015, a Memorandum was issued by the City Mayor directing all heads of departments, offices and operating units to observe the requirement that all purchase requests (PRs) with an approved budget for the contract (ABC) amounting to P10 million and above must be accompanied by a resolution duly adopted by the City Council authorizing the Chief Executive to enter into such contract:

WHEREAS, the Purchase Request amounting to Ten Million Five Hundred Thirty-Two Thousand Seven Hundred Forty-Five Pesos (P10,532,745.00) was granted to the winning bidders for the aforementioned books to be distributed to different barangays in Districts 1,2,3,4,5 and 6 of Quezon City.

WHEREAS, pursuant to existing laws, rules and regulations, and in compliance with the February 25, 2015 Memorandum of the City Mayor requiring an authorization from the City Council for PRs with approved budget contract of P10 Million and above, this resolution is hereby made for said purpose.
