A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE FIFTEEN (15) UNITS OF MOTORCYCLE WITH SIDECAR IN THE AMOUNT OF THREE MILLION FORTY NINE THOUSAND THREE HUNDRED SIXTY FIVE PESOS (P3,049,365.00) TO BE DONATED TO THE VARIOUS BARANGAYS IN DISTRICT 6, QUEZON CITY, CHARGEABLE AGAINST THE FUNDS OF THE OFFICE OF COUNCILOR CANDY A. MEDINA.
