A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY QUEZON CITY GOVERNMENT, THROUGH MAYOR HERBERT M. BAUTISTA, AND COMMONWEALTH HOSPITAL AND MEDICAL CENTER HEALTH GLOBAL INTERNATIONAL, INC., REPRESENTED BY DR. JUAN A. LAGUNZAD, FOR THE USE OF TANDANG SORA AND BANLAT HEALTH CENTERS AS LEARNING AND TRAINING VENUE FOR THE FAMILY AND COMMUNITY MEDICINE RESIDENTS OF COMMONWEALTH HOSPITAL AND MEDICAL CENTER.

WHEREAS, the 1987 Constitution mandates the State to protect and promote the right to health of the people, and to instill health consciousness among them;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, directs the local government units to ensure and support the promotion of health and safety of their constituents;

WHEREAS, Commonwealth Hospital and Medical Center Health Global International, Inc., a duly organized corporation existing under Philippine laws, currently owns and operates the Commonwealth Hospital and Medical Center located in CHMC Neopolitan Business Park Regalado Highway Novaliches, Quezon City;

WHEREAS, Commonwealth Hospital and Medical Center has a Family Medicine Residency Training Program, which is an academic requirement that includes community immersion program, use of health centers and practicum for its Family and Community Medicine Residents and Pre-residents;



WHEREAS, in support of Commonwealth Hospital and Medical Center's training program, the Quezon City Government is eager to allow Tandang Sora and Banlat Health Centers to be a learning and training venue for their Family and Community Medicine Residents;

WHEREAS, among the salient provisions of the Memorandum of Agreement are the following:

Commonwealth Hospital and Medical Center shall:

- *Provide primary health care program to families;*
- *Make health services accessible by consultation and thru morbidity clinics;*
- *Assist in the implementation of public health programs such as Expanded Program Immunization (EPI), Family Planning (FP), Direct Observed Treatment Short Courses (DOTS), Communicable and Non-Communicable Disease Control Program and Healthy Lifestyle Programs through consultations, lectures, and outreach programs; and*
- *Empower the community to become health conscious and self-reliant.*

Quezon City Government, through the City Health Office, shall:

- *Provide place for consultation and other community activities;*
 - *Provide logistics and other supplies for use of doctors, if available;*
 - *Allow Family Medicine Residents to conduct research evaluation related to the activities in the community; and*
 - *Supervise rotating residents during clinical consultations and outreach activities.*

WHEREAS, the contracting parties are willing to acknowledge their joint responsibility and undertaking under the Memorandum of Agreement and find that the provisions thereof are fair and reasonable;


WHEREAS, pursuant to Section 455 (b) (1) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the Memorandum of Agreement entered into by the Quezon City Government, through Mayor Herbert M. Bautista, and Commonwealth Hospital and Medical Center Health Global International, Inc., represented by Dr. Juan A. Lagunzad, for the use of Tandang Sora and Banlat Health Centers as learning and training venue for the Family and Community Medicine Residents of Commonwealth Hospital and Medical Center.

RESOLVED, FURTHER, that the Memorandum of Agreement (MOA), entered into by the Quezon City Government and Commonwealth Hospital and Medical Center be made an integral part hereof.


