RESOLUTION NO. SP- 8 3 7 7 s-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, ON BEHALF OF THE QUEZON CITY GOVERNMENT, TO PURCHASE ONE (I) UNIT OF MOTOR VEHICLE IN THE AMOUNT OF FIVE HUNDRED NINETY FIVE THOUSAND EIGHT HUNDRED NINETY THREE PESOS (PHP595,893.00) TO BE TAKEN FROM THE FUNDS OF THE CITY PLANNING AND DEVELOPMENT OFFICE INTENDED FOR MONITORING OF VARIOUS PROGRAMS AND PROJECTS OF THE LAND BANKING COMMITTEE OF THE SAID OFFICE.

WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", provides that the City Mayor shall represent the City in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.
