RESOLUTION NO. SP- **6383** _____, S-2015

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF RESCUE WATER PILLOW TANK AMOUNTING TO ONE MILLION FIVE HUNDRED THIRTY ONE THOUSAND PESOS (PHP1,531,000.00), INTENDED FOR THE USE OF THE RISK REDUCTION MANAGEMENT PROGRAMS OF THE QUEZON CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (QCDRRMC), TO BE CHARGED AGAINST THE FUNDS OF THE CITY MAYOR'S OFFICE.

WHEREAS, the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC) requested for the purchase of rescue water pillow tank that will be utilized in times of calamity;

WHEREAS, the specifications of the Rescue Water Pillow Tank that will be procured shall be as follows:

Specifications: 10,000 Liters Industrial Grade Portable Water Tank

Materials :

- 30 ounce Elvaloy
- Collapsible, flexible storage tanks
- Auto pressure valve built-in: Preventing excessive expansion
- 150 9001, EN13731 Certificate (last)
- (Filled: 0.8 meter)
- Secondary containment accessories:
- Confusion pad: 26 feet x 24 ounce nonwoven
- Compression pad for protection of tech from abrasive surfaces
- 4 feet Hose package that include:
 - 4 inches fill/discharge value
 - 4 inches x 10 feet by cam hose assy
 - 2 inches drain value
 - 2 inches x 10 feet drain hose assy

Weight: 41 kilogram (empty)

Size: 10,000 Liter, 5.5 meter x 3.0 meter (empty)

WHEREAS, pursuant to Administrative Order No. 15, amending Administrative Order No. 233, Series of 2008, the City Mayor, Honorable Herbert M. WHEREAS, as stated in Section 455 (b) (1)(vi) of Republic Act. No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor, as the chief executive of the city government, shall represent the city in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.


NOW, THEREFORE,
