RESOLUTION NO. SP- 6386 , S-2015

A RESOLUTION RATIFYING THE CONTRACT OR AGREEMENT ENTERED INTO BY THE HONORABLE MAYOR OF QUEZON CITY WITH THE WINNING BIDDERS/CONTRACTORS FOR THE PROVISION OF SERVICES AND SUPPLIES UNDERTAKEN BY THE OFFICE OF THE SECRETARY TO THE MAYOR OF THE QUEZON CITY GOVERNMENT IN THE AMOUNT OF SIX MILLION ONE HUNDRED FIFTY ONE THOUSAND NINE HUNDRED NINETY FOUR PESOS (PHP6,151,994.00).

WHEREAS, Section 356 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that the procurement or acquisition of supplies and services by local government units (LGUs) shall be made through competitive public bidding;

WHEREAS, Section 455 (b) (l) (vi) of the same Act provides that the City Mayor shall represent the City in all its business transactions and sign on its behalf contracts or agreement upon authority of the Sangguniang Panlungsod, or pursuant to a law or ordinance;

WHEREAS, second paragraph of Section 24 of Ordinance No. SP-2345, S-2014, otherwise known as the 2015 General Appropriations Ordinance of Quezon City provides that the City Mayor is hereby authorized to enter into and sign contracts for the construction, installation, improvement, expansion, operation and maintenance of public infrastructure and such other contracts whose amount does not exceed Ten Million Pesos (Php10,000,000.00) and duly appropriated herein;

WHEREAS, the last paragraph of Section 24 of the same appropriations ordinance provides that the Sangguniaang Panlungsod, through a resolution, shall ratify and confirm all that the City Mayor may lawfully do or cause to be done under and by virtue of the said appropriations ordinance;
