WHEREAS, Congressman Manny Pacquiao's phenomenal rise as Professional World boxing Icon started with a smashing 8th round knockout victory against Chatchai Sasakul (a.k.a. 3K Battery) of Thailand in the Flyweight Division;

WHEREAS, from the minimum weight division, Congressman Manny Pacquiao established an unprecedented record of emerging as Eight Division Champion and 9-time World Champion from Flyweight, Super Bantamweight (against Ledwaba of South Africa); Featherweight (against Marco Antonio Barrera); Super Featherweight (against Juan Manuel Marquez); Lightweight (against David Diaz); Welterweight (against Oscar de la Hoya) Junior Welterweight (against Miguel Cotto) and Super Welterweight (against Margarito).
