A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT WITH THE WINNING BIDDERS FOR THE PURCHASE OF BITUMINOUS PRIME COAT (ITEM 302) AND BITUMINOUS CONCRETE SURFACE COARSE (ITEM 310) FOR ASPHALT OVERLAY (FDLRC).

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance;

WHEREAS, the Office of the City Mayor is requesting for an authorization to enter into a contract/agreement with the winning bidders for the purchase of Bituminous Prime Coat (Item 302) and Bituminous Concrete Surface Coarse (Item 310) for Asphalt Overlay (FDLRC) having an amount of Seventy Six Million Eight Hundred Ninety Five Thousand Two Hundred Seventy One Pesos and Seventy Centavos (Php76,895,271.70) and above, specifically identified as follows:

NOW, THEREFORE,




