WHEREAS, the Office of the City Mayor is requesting for authorization to enter into a contract/agreement with the winning bidders for the purchase of Bituminous Prime Coat (Item 302) and Bituminous Concrete Surface Coarse (Item 310) for Asphalt Patching (FD) having an amount of Sixteen Million Six Hundred Fifty Three Thousand Nine Hundred Ninety Two Pesos and Seventy Centavos (Php16,653,992.70) and above, specifically identified as follows:



NOW, THEREFORE,




