Baustista, to enter into contracts with Spouses Jose and Fe Urdaneta and Luzon Development Bank, for the purchase of a certain parcels of land identified as Lot 1-A (LRC) Psd-317390 and Lots 4-H, 4-I, 4-J & 4-K (LRC) Pcs-408445 located at Kaligtasan Street, Barangay Holy Spirit and Corregidor Street, Barangay Matandang Balara, Quezon City, respectively.
