RESOLUTION NO. SP- **6397**, S-2015

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY THE QUEZON CITY GOVERNMENT, THROUGH MAYOR HERBERT M. BAUTISTA, AND ATENEO DE MANILA UNIVERSITY, REPRESENTED BY DR. ALFREDO RA. BENGZON, FOR THE OPERATION OF THE LEARNING EXPERIENCES IN COMMUNITIES PROGRAM OF ATENEO SCHOOL OF MEDICINE AND PUBLIC HEALTH, IN BATASAN SUPER HEALTH CENTER AND CUBAO HEALTH CENTER.

WHEREAS, the 1987 Constitution mandates the State to protect and promote the right to health of the people, and to instill health consciousness among them;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, directs the local government units to ensure and support the promotion of health and safety of their constituents;

WHEREAS, Ateneo de Manila University, through the Ateneo School of Medicine and Public Health, is a private educational institution dedicated to the education, training and formation of medical students obtaining a degree in Doctor of Medicine and Master in Business Administration;

WHEREAS, the Learning Experiences in Communities Program of Ateneo de Manila University seeks to establish a community based partnership with the Quezon City Government that will provide support and technical expertise in the field of public health in Batasan Super Health Center and Cubao Health Center for the learning experiences of the institution's medical students;




WHEREAS, the Quezon City Government, through Mayor Herbert M. Bautista, recognizes the importance and benefits of the program of Ateneo de Manila University to the residents of the city, as well as to the students of the university, and is keen to enter into contract with the said party;

WHEREAS, among the salient provisions of the Memorandum of Agreement are the following:

The Ateneo de Manila University, through the Ateneo School of Medicine and Public Health shall:

- Orient the Quezon City Government, through the Quezon City Health Department, regarding the principles and framework of the Learning Experiences in Communities and to the concepts and practices of Service-Learning and Campus-Community Partnership;*
- Provide the necessary logistics, supplies and materials in carrying out the projects or initiatives that the Ateneo School of Medicine and Public Health students and Quezon City Government will agree on in the spirit of Service-Learning. All operational and institutional costs shall be the responsibility of the Ateneo de Manila University while and during the period of the Learning Experiences in Communities Program implementation;*
- Provide academic and faculty support to the collaborative undertaking of Ateneo School of Medicine and Public Health and Quezon City Government and its community;*
- Provide the Quezon City Government with a Preceptor Fee in the amount of Php88,200.00 for the valuable support of the Learning Experiences in Communities Program. The said amount will be released in the following tranches:*

a. 50% of the initial amount upon signing of the Memorandum of Agreement

- b. 50% of amount upon completion of the end-program assessment;

The Quezon City Government, through the Quezon City Health Department, shall:

- *Assign a Medical Officer IV as field preceptor who shall have the following responsibilities:*
 - a. *Serves as the main resource person of the students of Ateneo School of Medicine and Public Health, and*
 - b. *Advise and assist the Ateneo School of Medicine and Public Health students in coordinating their work with the community;*
- *Have the option to adopt and continue the implementation of the project, based on its applicability and availability of resources.*




WHEREAS, the contracting parties are willing to acknowledge their joint responsibility and undertaking under the Memorandum of Agreement and find that the provisions thereof are fair and reasonable;

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify the Memorandum of Agreement entered into by the Quezon City Government, through Mayor Herbert M. Bautista, and Ateneo de Manila University, represented by Dr. Alfredo RA. Bengzon, for the operation of the Learning Experiences in Communities Program of Ateneo School of Medicine and Public Health, in Batasan Super Health Center and Cubao Health Center.


