RESOLUTION NO. SP- 6398 , S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ALLOCATE TWO MILLION PESOS (PHP2,000,000.00) FINANCIAL ASSISTANCE TO PAY FOR THE SALARIES OF NEWLY HIRED CONTRACTUAL TEACHERS WHO ARE TEACHING THE ONE THOUSAND SIX HUNDRED SEVENTY-SEVEN (1,677) STUDENT-TRANSFEREES FROM QUEZON CITY INFORMAL SETTLER FAMILIES RELOCATED IN THE MUNICIPALITY OF PANDI, BULACAN.

WHEREAS, informal settler families (ISFs) in Quezon City were relocated to resettlement sites in the Municipality of Pandi, Bulacan;

WHEREAS, the Pandi Residences Elementary School and Real de Cacarong Elementary School have absorbed the 1,677 student-transferees from kindergarten to Grade VI who are children of relocated Quezon City ISFs;

WHEREAS, to cater to these students, the Department of Education (DepEd) Schools Division of Bulacan, District of Pandi has hired twenty-five (25) contractual teachers with a monthly salary of Ten Thousand Pesos (Php10,000);

WHEREAS, the Municipal Mayor of Pandi, Bulacan, Honorable Enrico A. Roque, sent a letter dated June 9, 2015 to Honorable Mayor Herbert M. Bautista, endorsing the request of Ms. Dulce Regina C. Flores, Ph.D., DepEd District Supervisor of Pandi, seeking for financial allocation of Two Million Pesos (Php 2,000,000.00) to pay for the salaries of the newly hired contractual teachers.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Herbert M. Bautista, to allocate Two Million Pesos (Php2,000,000.00) financial assistance to pay for the salaries of newly hired contractual teachers who are teaching the One Thousand Six Hundred Seventy-Seven (1,677) student-transferees from Quezon City informal settler families relocated in the Municipality of Pandi, Bulacan.
