RESOLUTION NO. SP- **6400**, S-2015

A RESOLUTION AUTHORIZING THE MAYOR OF QUEZON CITY, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH, REPRESENTED BY DR. ARIEL I. VALENCIA, ON THE TRANSFER OF FUNDS IN THE AMOUNT OF SEVEN HUNDRED FIVE THOUSAND ONE HUNDRED EIGHTY EIGHT PESOS (PHP705,188.00) TO PROVIDE SUPPORT FOR THE ESTABLISHMENT AND OPERATION OF HIV SATELLITE TREATMENT HUB IN KLINIKA BERNARDO.

WHEREAS, the 1987 Constitution mandates the State to protect and promote the right to health of the people, and to instill health consciousness among them;

WHEREAS, one of the priority programs of the Department of Health, and in line with its Millennium Development Goals, the National STI/HIV and AIDS is the government's commitment to control and prevent Sexually Transmitted Infection (STI), Human Immunodeficiency Virus (HIV), and Acquired Immunodeficiency Syndrome (AIDS) in the country;

*WHEREAS, as one of the objectives of 5<sup>th</sup> AIDS Medium Term Plan (AMTP V) for 2016, the country will have prevented the further spread of HIV infection and reduced the impact of the disease on individuals, families, sectors and communities;*

*WHEREAS, the Department of Health-National Capital Regional Office (DOH-NCRO) promotes prevention and cure of infectious diseases including STI/HIV and AIDS within Metro Manila. In coordination with the National Center for Disease Prevention and Control, the DOH-NCRO deems it necessary to establish Satellite Treatment Hubs in selected sites in Metro Manila;*

*WHEREAS, the Satellite Treatment Hub will provide treatment, care, and support to people living with HIV, as well as give services to clients with Sexually Transmitted Infections;*

*WHEREAS, the DOH-NCRO deems it necessary to augment the needs of the LGUs in terms of infrastructure, equipment, drugs and medicine, supplies and materials to ensure the functionality of Satellite Treatment Hub;*

*WHEREAS, the Infectious Disease Cluster (IDC) of the DOH-NCRO allotted funds from the CY 2014 DOH Attributes (other infectious diseases and emerging and re-emerging diseases) in the amount of Five Million Six Hundred Forty One Thousand Five Hundred Four Pesos (PHP5,641,504.00) as support to Satellite Treatment Hubs;*

*WHEREAS, the allotment will be utilized to support the establishment of Satellite Treatment Hubs in eight (8) health facilities within the region;*

*WHEREAS, one of these identified health facilities is operating under the Local Government of Quezon City;*

*WHEREAS, the amount of Seven Hundred Five Thousand One Hundred Eighty Eight Pesos (Php705,188.00) shall be provided to support the establishment and operations of the HIV Satellite Treatment Hub in Klinika Bernardo, Barangay Kamuning, Quezon City;*

*WHEREAS, consistent with the vision of the State and the mandate of the Constitution, the contracting parties acknowledged their joint responsibility and undertaking under the Memorandum of Agreement in the pursuit of addressing the pressing concern on mitigating the spread of HIV.*
