RESOLUTION NO. SP- 6404 , S-2015

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO RICSONS PROPERTIES MANAGEMENT AND SERVICES, INC., FOR THE CONSTRUCTION OF RICSONS PLACE – A THREE (3)-STOREY OFFICE AND COMMERCIAL BUILDING LOCATED AT LOTS I AND 3, BLOCK 9, ATHERTON STREET CORNER ADRIAN STREET, BARANGAY NORTH FAIRVIEW, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

WHEREAS, the City Council is empowered under the Local Government Code of 1991 to issue Certificate of Exception in consonance with the enacted Quezon City Comprehensive Zoning Ordinance No. SP-918, S-2000, as amended, subject to classification and zoning;

WHEREAS, Ricsons Properties Management and Services, Inc., owner of the property, is applying for a Certificate of Exception for the construction of Ricsons Place – a Three (3)-Storey Office and Commercial Building located at Lots 1 and 3, Block 9 Atherton Street corner Adrian Street, Barangay North Fairview, Quezon City;

WHEREAS, however, the zone classification falls on the Medium Density Residential Zone (R-2), such that the project activity is not permissible;

WHEREAS, the Barangay Council of Barangay North Fairview interposes no objection to the said project;

WHEREAS, the project will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the applicant has complied with and is further ready, able and willing to comply with all the prescribed requirements relative thereto, pursuant to and is in keeping with the Quezon City Comprehensive Zoning Ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Ricsons Properties Management and Services. Inc., for the construction of Ricsons Place – a Three (3)-Storey Office and Commercial Building located at Lots 1 and 3, Block 9, Atherton Street corner Adrian Street, Barangay North Fairview, Quezon City, allowing deviation from the restrictions of the Quezon City Comprehensive Zoning Ordinance No. SP-918, S-2000, as amended.
