A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE CITY MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COUNCIL FOR THE ESTABLISHMENT OF A NATIONAL CHILD DEVELOPMENT CENTER (NCDC) IN QUEZON CITY.

WHEREAS, in accordance with Republic Act No. 10410, otherwise known as the Early Years Act of 2013, the Early Childhood Care and Development (ECCD) Council is mandated to institutionalize a National System for Early Childhood Care and Development (ECCD) that is comprehensive, integrative and sustainable that will involve multi-sectoral and inter-agency collaboration at the national and local levels to promote the optimum growth and development of Filipino children age zero (0) to four (4) years:

WHEREAS, the ECCD Council intends to establish a National Child Development Center (NCDC) to serve as its laboratory for the different modes of delivery of center-based ECCD programs, including the provision of contents and teachers;

WHEREAS, the Quezon City Government has been chosen by the ECCD Council to establish the said NCDC;

WHEREAS, a Memorandum of Agreement has been prepared providing for the terms and conditions for the establishment of the NCDC;

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and shall sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, represented by the City Mayor, to enter into a Memorandum of Agreement (MOA) with the Early Childhood Care and Development (ECCD) Council for the establishment of a National Child Development Center (NCDC) in Quezon City.
