RESOLUTION NO. SP- 6418 . S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT TO SELL WITH THE HEIRS OF SPOUSES MELENCIO R. GAJONERA AND VICTORINA F. GAJONERA OVER A PARCEL OF LAND LOCATED AT MAKATARUNGAN STREET, BARANGAY SAN VICENTE, QUEZON CITY, OWNED BY THE CITY GOVERNMENT IN FURTHERANCE OF THE SOCIALIZED HOUSING PROJECT OF THE LOCAL GOVERNMENT OF QUEZON CITY.

WHEREAS, the City Government of Quezon City is the registered owner of a parcel of land identified as Lot 12 Block 24, Psd-13-008179, registered under TCT No. RT-36306, located at Makatarungan Street, Barangay San Vicente, Quezon City;

WHEREAS, as per Subdivision Plan Psd-13-008179 approved on February 12, 1986, by the Land Management Sector, Department of Environment and Natural Resources (DENR), Block 24 Psd-56573 was subdivided into fifteen (15) lots. Out of the thirteen (13) awardees only the late Melencio Gajonera was not able to acquire the property occupied by them identified as Lot 12-L Psd-13-008179 with an area of 120 square meters, for non-compliance with the easement requirements;

WHEREAS, the heirs of the late Spouses Melencio R. Gajonera and Victorina F. Gajonera who, by operation of law, are entitled to inherit the said lot and the improvement in accordance with the law on intestate succession, has already complied with the easement requirement, and they are willing to buy the said property;

WHEREAS, the City Appraisal Committee, upon the review and recommendation of the Technical Working Group (TWG), has determined that the fair value of the lot is Five Thousand Eight Hundred Pesos (P5,800.00) per sq. meters;

WHEREAS, in the letter dated August 20, 2014, the heirs of the late Spouses Melencio R. Gajonera and Victorina F. Gajonera informed the City Government that they are amenable to the appraised value recommended by the City Appraisal Committee;

WHEREAS, in order to facilitate the transfer of the said parcel of land it is necessary to authorize the Honorable City Mayor to enter into a contract to sell and/or Deed of Absolute of Sale with the heirs of the late Spouses Melencio R. Gajonera and Victorina F. Gajonera;

WHEREAS, Sections 22 (c) and 455 (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", requires the prior authorization of the City Council before the Local Chief Executive can enter into a contract on behalf of the local government unit;

WHEREAS, Section 455 (b) (l) (vi) of the same Act provides that the City Mayor shall represent the City in all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.

Bautista, to enter into a Contract to Sell and/or Deed of Absolute Sale with the heirs of the late Spouses Melencio R. Gajonera and Victorina F. Gajonera over a parcel of land located at Makatarungan Street Barangay San Vicente, Quezon City owned by the City Government, in furtherance of the Socialized Housing Project of the Local Government of Quezon City.
