
*WHEREAS, Brother Eduardo embodies a spiritual leader who inspires the flock he shepherds through his own strict compliance with Christian teachings;*

*WHEREAS, the Iglesia Ni Cristo steadfastly upholds the Christian doctrine of caring for one another especially for the crestfallen neighbors.*


*NOW, THEREFORE,*
