RESOLUTION NO. SP-_ 6431 ___, S-2015

A RESOLUTION AUTHORIZING THE LAND BANK OF THE PHILIPPINES TO DEBIT THE QUEZON CITY GOVERNMENT'S DEPOSIT ACCOUNT WITH THE LAND BANK OF THE PHILIPPINES, QUEZON CITY HALL. BRANCH, TO EFFECT PAYMENT NECESSARY FOR THE IMPORTATION OF GOODS BY THE QUEZON CITY GOVERNMENT.

WHEREAS, the Quezon City Government engages into the importation of goods which are necessary for the efficient and effective delivery of basic services and for the provision of adequate facilities;

WHEREAS, in the procurement of goods under Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, goods supplied from abroad shall be imported by the supplier with the assistance and facilitation of the Quezon City Government as to the necessary and incidental payments of imported goods;

WHEREAS, Land Bank of the Philippines has adopted an internet payment system otherwise known as the Payment Application Secure System V.5 (PASS 5) to effect payment for taxes and duties imposed by the Bureau of Customs and the corresponding service charges;

WHEREAS, the Quezon City Government intends to enroll in PASS 5 to facilitate the payment for taxes and duties imposed by the Bureau of Customs on the importation of goods;

WHEREAS, the enrollment in PASS 5 requires authority from the Quezon City Government to debit the appropriate Depository Accounts opened and maintained with the Land Bank of the Philippines, Quezon City Hall Branch for the payment of taxes and duties imposed by the Bureau of Customs and the corresponding bank service charges.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Land Bank of the Philippines to debit the Quezon City Government's deposit account with the Land Bank of the Philippines, Quezon City Hall Branch, to effect payment necessary for the importation of goods by the Quezon City Government.
