*A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, WITH THE WINNING BIDDER, GOLDEN SKY TRAVEL AND TOURS, FOR THE UNDERTAKING OF FOREIGN ACADEMIC TRAINING OF QUEZON CITY BARANGAY OFFICIALS IN THE REPUBLIC OF SINGAPORE ON AUGUST 30 – SEPTEMBER 2, 2015.*

*WHEREAS, pursuant to Section 22 (c), Chapter II, Title I, Book I of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City and enter into a contract in its behalf upon the authority of the Sanggunian;*

*WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160 provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf, all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance;*

*WHEREAS, the City Government through the Office of the City Mayor has sponsored the Local Executive Courses for Quezon City elective Barangay Officials which includes the Foreign Academic Training (FAT) in the Republic of Singapore which shall be supervised by Urban Planners of the Urban Redevelopment Authority (URA);*

WHEREAS, the City Government has allocated the sum of P14,850,000.00 for the undertaking of Foreign Academic Training (FAT) of 140 Barangay and 10 City Officials/Barangay Operations Center (BOC) Staff;


WHEREAS, the City Budget Office has certified that funds are available and chargeable under the Other Maintenance and Operating Expenses, Social Services Program of the Office of the City Mayor.

NOW, THEREFORE,



# CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

That, this Contract entered into by and between, **THE QUEZON CITY GOVERNMENT**, a Public Corporation created by law, with principal business address located at Quezon City Hall, Elliptical Road, Diliman, Quezon City, represented by **HON. HERBERT M. BAUTISTA**, in his capacity as **CITY MAYOR** and shall hereinafter referred to as **The City Government**;

- and -

**GOLDEN SKY TRAVEL AND TOURS**, an Accredited Travel Agency engaged in the trade of travel and tours (foreign and local), booking services and other allied services, with principal address at Unit 225-226, Manila Executive Regency, 1200 Jorge Bocobo Street, Ermita, Manila, represented by **MS. RHODORA F. SANTOS** in her capacity as President and shall hereinafter referred to as **The Second Party**.

## WITNESSETH THAT:

Whereas, **The City Government** will be undertaking a 'Foreign Academic Training (FAT)' to those barangay officials who have completed the Local Executive Courses. The said study tour is part and parcel of the training program with the view of enhancing and enriching the knowledge of these barangay officials in the field of Urban Planning.

Whereas, **The City Government** through its representative the QC-Barangay Operations Center (BOC) is in need of the services of a competent and accredited Travel Agency that will provide the necessary requirements of **The City Government** in the conduct of the 'Foreign Academic Training (FAT)' in the Republic of Singapore.

Whereas, **The Second Party** whose line of business is primarily to provide services related to travel and tours, accommodations and other allied services, has the capacity and experience that meet all of the requirements of **The City Government** relative to the implementation of its 'Foreign Academic Training (FAT)'.

Whereas, after due consideration, **The City Government** has agreed to hire the services of **The Second Party**.

**NOW, THEREFORE**, for and in consideration of the foregoing premises, both parties agree as they hereby agree to the following terms and conditions:

## TERMS AND CONDITIONS.

### I. The City Government:

- The City Government shall avail the services of **The Second Party** on **AUG. 30 - SEPT. 02, 2015** for the undertaking of Foreign Academic Training (FAT) in the Republic of Singapore composed of 150 Barangay and City Officials.
- The City Government shall pay **The Second Party** the total amount of Fourteen Million Eight Hundred Fifty Thousand Pesos Only (P14,850,000.00), under the following mode of payment:
  - ❖ 50% Down Payment of the full amount for accommodation before departure for the FAT - P 6,000,000.00
  - ❖ And the payment of the remaining balance after the completion of the FAT - P 8,850,000.00
  - \* Please refer to the attached PERT
- The payment of the amount due and payable under this Contract shall be made upon presentation by **The Second Party** to **The City Government** of the corresponding Statement of Account; a) initial billing of 50% representing the down payment (accommodation only) and b) billing statement for the remaining balance of this contract after the completion of trip covering the services actually incurred during the conduct of the FAT.

and/or deduct from the total amount of this contract all or portion of the services stipulated herein that have been failed or neglected to be provided by The Second Party.

## II. The Second Party:

- The Second Party shall ensure to provide the following services to The City Government: **1) Room Accommodation** - in Hotel with single and double sharing to the participants for Four (4) days and three (3) nights and the use of function room in a hotel; **2) Meals** - (buffet), Breakfast, Lunch and Dinner, including meals during the fellowship nights; **3) Round Trip Transfer** - (Airport-Hotel-Airport); **4) Shuttle Service** - a) to Urban Redevelopment Authority (URA) and on-site tour of on-going project/s (River Cruise), b) Courtesy Call to the Philippine Consulate and c) shuttle service from Quezon City Hall - Airport (send off); **5) Fees and Taxes** - a) Fees and charges to be paid to URA for the Foreign Academic Training (FAT) and b) Terminal Fees and other Duties or Taxes that may be imposed during the conduct of FAT by both Manila and Singapore and **6) Others** - as may be agreed upon by The City Government and The Second Party during the course of the study tour.
- The Second Party shall not be responsible for any lost or damage of item/s in the room (hotels) where the participants are assigned and billeted; fines and penalty/fines for violations of existing laws and/or ordinances that are being imposed by the Government of Republic of Singapore.
