A RESOLUTION AMENDING RESOLUTION NO. SP-5725, S-2013, ENTITLED "A RESOLUTION AUTHORIZING THE BARANGAY COUNCIL OF BARANGAY PINAGKAISAHAN TO CONSTRUCT AN ADDITIONAL SECOND FLOOR WITH ROOF DECK TO THEIR EXISTING BARANGAY HALL LOCATED ALONG ERMIN GARCIA STREET BESIDE RAMON MAGSAYSAY (CUBAO) HIGH SCHOOL, BARANGAY PINAGKAISAHAN, QUEZON CITY".

WHEREAS, Resolution No. SP-5725, S-2013 authorizes the Barangay Pinagkaisahan to construct an additional Second Floor to their existing Barangay Hall located along Ermin Garcia Street beside Ramon Magsaysay (Cubao) High School;

WHEREAS, the ongoing construction of the Barangay Hall was funded by the Department of Public Works and Highway;

WHEREAS, while the first floor of the barangay hall is undergoing construction, the Department of Public Works and Highway informed the Barangay Council of Barangay Pinagkaisahan that they allocated fund for the construction of the second floor with roof deck of the said Barangay Hall;
