RESOLUTION NO. SP- 643 7 , S-20 5

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO METRO MARKETING CORPORATION FOR THE CONSTRUCTION OF A FIVE-STOREY WAREHOUSE LOCATED AT NO. 02, BITUAN STREET, BARANGAY DOÑA IMELDA, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-2200, S-2013, AS AMENDED.

WHEREAS, Metro Marketing Corporation is the project owner and developer of a two storey-building located at No. 2, Bituan Street, Barangay Doña Imelda, Quezon City;

WHEREAS, the Barangay Council of Barangay Doña Imelda and the residents therein interposed no objection to the said project;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, in accordance with the provisions of Articles IV, Article V, Article VI and Article VIII of Ordinance No. SP-2200, S-2013 as amended, and its Implementing Rules and Regulations, an Exception is required for a project to which the proposed project falls under.
