RESOLUTION NO. SP- 6445 _, S-2015

A RESOLUTION RATIFYING THE CONTRACT OR AGREEMENT ENTERED INTO BY THE HONORABLE MAYOR OF QUEZON CITY WITH THE WINNING BIDDERS/CONTRACTORS FOR THE PROVISION OF SERVICES AND SUPPLIES UNDERTAKEN BY THE OFFICE OF THE VICE MAYOR OF THE QUEZON CITY GOVERNMENT IN THE AMOUNT OF ONE HUNDRED SIXTEEN MILLION THREE HUNDRED THIRTY FOUR THOUSAND EIGHT HUNDRED SEVENTY THREE PESOS AND FIFTY FOUR CENTAVOS (PHP116, 334,873.54).

WHEREAS, Section 455 (b) (1) (vi) of the same Act provides that the City Mayor shall represent the City in all its business transactions and sign on its behalf contracts or agreements upon authority of the Sangguniang Panlungsod, or pursuant to a law or ordinance:


WHEREAS, the second paragraph of Section 24 of Ordinance No. SP-2345, S-2014, otherwise known as the 2015 General Appropriations Ordinance of Quezon City, provides that the City Mayor is hereby authorized to enter into and sign contracts for the construction, installation, improvement, expansion, operation and maintenance of public infrastructure and such other contracts whose amount does not exceed Ten Million Pesos (Php10,000,000.00) and duly appropriated herein;

WHEREAS, the last paragraph of Section 24 of the same appropriations ordinance provides that the Sangguniaang Panlungsod, through a resolution, shall ratify and confirm all that the City Mayor may lawfully do or cause to be done under and by virtue of the said appropriations ordinance;
