WHEREAS, in compliance with the provisions of Presidential Decree Nos. 957 and 1216, WIL-VIC Construction and Development Corporation hereby donates and conveys in favor of the Quezon City Government, three (3) Road lots and One (1) open space covered by Transfer Certificates of Title (TCT) Nos. 22433, 22434, 22435 and 22391 of the Registry of Deeds of Quezon City containing an area of Two Thousand Nine Hundred Thirty Four (2,934) Square Meters, Five Hundred Thirty Seven (537) Square Meters, Seven Hundred Thirty Three (733) Square Meters, and One Thousand Thirty Three (1,033) square meters, more or less, respectively.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Herbert M. Bautista, to sign and accept the Deed of Donation and Acceptance with the Donor, WIL-VIC Construction and Development Corporation, represented by its President William Ong Genato consisting of three (3) road lots and one (1) open space in Villa Rebecca Subdivision, Barangay Tandang Sora, Quezon City.
