WHEREAS, in compliance with the provisions of Republic Act No. 440, entitled: "An Act to Amend Section Forty-four of Act numbered Four Hundred and Ninety-six, otherwise known as the Land Registration Act", Mrs. Teodora Delos Santos, hereby donates and conveys in favor of the Quezon City Government, one (1) Lot, (LRC) (LRC) Psd-13-018035 and covered by TCT No. 46232 of the Registry of Deeds of Quezon City consisting of One Hundred Ninety Six (196) Square Meters more or less;
