RESOLUTION NO. SP- 6471 __, S-2015

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR OF QUEZON CITY TO ENTER INTO CONTRACTS OR AGREEMENTS WITH THE WINNING BIDDERS/CONTRACTORS FOR THE PURCHASE OF GROCERY ITEMS AND EVENT MANAGEMENT SERVICE UNDERTAKEN BY THE OFFICE OF THE CITY MAYOR WITH A TOTAL AMOUNT OF TWENTY NINE MILLION NINETY EIGHT THOUSAND SIX HUNDRED SIX PESOS AND FIFTY CENTAVOS (PHP29,098,606.50).

WHEREAS, Section 356 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that the procurement or acquisition of supplies and services by local government units (LGUs) shall be made through competitive public bidding:

WHEREAS, Section 455 (b) (l) (vi) of the same Code provides that the City Mayor shall represent the City in all its business transactions and sign on its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance;

WHEREAS, the Commission on Audit (COA) issued Audit Observation Memorandum 2014-11-C (2013), citing as basis the Supreme Court decision in the case of Hon. Gabriel Quisumbing v Hon. Gwendolyn F. Garcia (G.R. No. 175527), requiring the City Council to give prior authorization to the City Mayor before any expenses/disbursement charged against a lump sum appropriation can be made;

WHEREAS, pursuant to the Memorandum issued by the Honorable Mayor Herbert M. Bautista directing all department heads, offices and operating units to observe the requirement that all Purchase Request with an approved budget for the contract amounting to Ten Million Pesos and above must be accompanied by a resolution duly adopted by the City Council authorizing the Chief Executive to enter into such contracts;
