A RESOLUTION URGING THE HONORABLE MAYOR HERBERT M. BAUTISTA TO INSTALL CLOSED-CIRCUIT TELEVISION (CCTV) CAMERAS IN ALL MAJOR THOROUGHFARES IN QUEZON CITY.

WHEREAS, the 1987 Constitution expressly provides that: "it is the policy of the State to maintain peace and order and to protect the life and property of the general public". The occurrence of hold-ups, murder, and other such crimes has become increasingly common in our major streets and it is considered alarming since many such incidents have been perpetrated in broad daylight while still a majority of them happening late night up to the wee hours in the morning;

WHEREAS, in addition, video recordings in CCTV cameras may be used as competent evidence in road accidents and/or cases involving violations of traffic laws and could be of great importance in determining the party at fault in such kind of mishaps;

WHEREAS, in spite of the significant use of CCTV cameras, not all major roads in Quezon City where Public Utility Vehicles (PUVs) pass along have CCTV cameras installed for monitoring and recording of road situations at all times. As such, it is harder to determine the true events that occurred during road mishaps and occurrence of criminal offenses;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable Mayor Herbert M. Bautista to install Closed-Circuit Television (CCTV) Cameras in all major thoroughfares in Quezon City.

RESOLVED, FURTHER, that copies of this Resolution be forwarded to the Honorable Mayor Herbert M. Bautista and to all other concerned city departments for their information and appropriate action.
