RESOLUTION NO. SP- **6475** , S-2015

A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY THE HONORABLE QUEZON CITY MAYOR HERBERT M. BAUTISTA WITH THE WINNING BIDDERS FOR THE PURCHASE OF VARIOUS SERVICES, MATERIALS, AND OFFICE EQUIPMENTS TO BE UTILIZED BY THE OFFICE OF THE SECRETARY TO THE MAYOR, TASK FORCE ON SOCIALIZED HOUSING AND DEVELOPMENT ON BLIGHTED AREAS, PARKS DEVELOPMENT AND ADMINISTRATION DEPARTMENT, AND THE OFFICE OF THE VICE MAYOR, FUNDED UNDER THE LUMP SUM APPROPRIATION, SOCIALIZED HOUSING FUND, AND THE DIAMOND JUBILEE FUND.

*WHEREAS, Section 356 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that the procurement or acquisition of supplies and services by local government units (LGUs) shall be made through competitive public bidding;*

*WHEREAS, Section 455 (b) (1) (vi) of the same Act provides that the City Mayor shall represent the City in all its business transactions and sign on its behalf contracts or agreement upon authority of the Sangguniang Panlungsod or pursuant to a law or ordinance;*

*WHEREAS, the Commission on Audit (COA) issued Audit Observation Memorandum 2014-11-C (2013), citing as basis the Supreme Court decision in the case of Hon. Gabriel Quisumbing vs. Hon. Gwendolyn F. Garcia (G.R. No. 175527), requiring the City Council to give prior authorization to the City Mayor before any expenses or disbursement will be charged against a budget lump sum appropriation;*







NOW, THEREFORE,


