RESOLUTION NO. SP- **6477**, S-2015

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO BY HONORABLE MAYOR HERBERT M. BAUTISTA, WITH THE TEACH FOR THE PHILIPPINES INC., (TFP), AND THE DEPARTMENT OF EDUCATION, DIVISION OF CITY SCHOOLS, QUEZON CITY FOR THE IMPLEMENTATION OF THE TFP PROGRAM FOR THE PERIODS SY 2015-2016 AND SY 2016-2017 IN SELECT PUBLIC ELEMENTARY SCHOOLS IN QUEZON CITY.

WHEREAS, Teach for the Philippines Incorporated (TFP), is one of the accredited Civil Society Organizations (CSOs) by the Quezon City Council under Ordinance No. SP 2233, S-2013, for having satisfactorily complied with the requirements for accreditation prescribed under Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, by virtue of Resolution No. SP-6334, S-2015, the City Mayor, Honorable Herbert M. Bautista, was authorized to sign a Memorandum of Agreement with the Department of Education, Division of Quezon City (DepEd-QC), represented by its Schools Division Superintendent - Officer-in-Charge, Dr. Helen Grace V. Go, and Teach for the Philippines, Incorporated (TFP), represented by its Chief Executive Officer, Ms. Margarita L. Delgado for the implementation of TFP's project which aims to aid in the transition of K to 12 Education Program through the continued implementation of the TFP program for the periods SY 2015-2016 and SY 2016-2017;

WHEREAS, DepEd-QC and the City Government recognize the nature of high-need public schools and welcome the continued implementation of the TFP Program which will: (1) provide Fellows in Philippine public schools in Quezon City; (2) continue the program in which education and non-education majors are trained to become successful and transformational teachers; (3) establish a long-term impact of TFP's presence in Quezon City for SY2015-2016 and SY 2016-2017 and (4) help in research and development for future education policies based on scientific evidence;

WHEREAS, among the salient provisions of the Memorandum of Agreement are the following:

Teach for the Philippines, Inc. shall:

- Recruit and select individuals to participate in the Program who will serve as Fellows;
- Conduct Pre-Service Training or Summer Training for the Fellows;
- Provide allowance of Fellows;
- Provide Fellows with various in-service professional development services and activities; and
- Provide DepEd QC and the City Government feedback on the K to 12 implementation.

DepEd-QC shall:

- Select the participating public elementary schools in Quezon City in collaboration with the Quezon City Government and TFP; and
- Commit to place Fellows in the designated Partner Schools.

Quezon City Government, shall:

- Select and designate the public elementary schools Partner Schools in collaboration with DepEd-QC and TFP;

- Commit to place Fellows in the designated Partner Schools; and
- Provide for the allowance and cost of training of the Fellows.


WHEREAS, pursuant to Section 455 (b) (1) of the Local Government Code of 1991, the City Mayor shall represent the City in all its business transaction and sign on its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod , or pursuant to law or ordinance.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Memorandum of Agreement (MOA) entered into by Honorable Mayor Herbert M. Bautista, with the Teach for the Philippines, Inc., (TFP), and the Department of Education, Division of City Schools, Quezon City, for the implementation of the TFP Program for the periods SY 2015-2016 and SY 2016-2017 in select public schools in Quezon City.
