A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ALLOW THE ROTARY INTERNATIONAL DISTRICT 3780 (QUEZON CITY) TO BEAUTIFY AND DEVELOP A QUADRANT (ISLAND) FRONTING THE ROTARY CENTER AS ITS ROTARY PLAZA LOCATED AT DON ALEJANDRO ROCES AVENUE CORNER MOTHER IGNACIA AVENUE, BARANGAY PALIGSAHAN, QUEZON CITY, SUBJECT FOR CONFIRMATION BY THE CITY COUNCIL.

WHEREAS, as enshrined under Section 445 (b) (l) (vi) of the 1991 Local Government Code of the Philippines, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, the Rotary International District 3780 (Quezon City), a non-profit and leading civic organization duly organized and existing under and by virtue of the laws of the Republic of the Philippines, expressed its heartfelt desire of leasing and developing a quadrant (island) fronting the Rotary Center as its Rotary Plaza located at Don Alejandro Roces Avenue corner Mother Ignacia Avenue, Barangay Paligsahan, Quezon City, subject for confirmation by the City Council;

WHEREAS, there is a valid and existing Contract of Lease dated June 30, 1995 entered into by and between the Quezon City Government and Rotary International District 3780 (Quezon City) involving a parcel of land with an area of One Thousand Fifty Six (1,056) Square Meters, more or less, situated at Roces Avenue, Quadrangle, Barangay Paligsahan, Quezon City pursuant to Resolution No. SP-229, S-94;

WHEREAS, the proposed development, beautification and maintenance of the entire quadrant shall be undertaken at the expense of the Rotary International District 3780 (Quezon City), for the benefit of the general public.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Herbert M. Bautista, to allow the Rotary International District 3780 (Quezon City) to beautify and develop a quadrant (island) fronting the Rotary Center as its Rotary Plaza located at Don Alejandro Roces Avenue corner Mother Ignacia Avenue, Barangay Paligsahan, Quezon City, subject for confirmation by the City Council.
