A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT OR AGREEMENT WITH THE WINNING SUPPLIER/BIDDER FOR THE PURCHASE OF MEDICAL, DENTAL AND LABORATORY SUPPLIES AMOUNTING TO TWENTY SIX MILLION SIX HUNDRED SIXTY FOUR THOUSAND FOUR HUNDRED FIFTY TWO PESOS AND FIFTY CENTAVOS (\$\mathbb{P}26,664,452.50), TO BE DISTRIBUTED TO OR USED BY, THE NOVALICHES DISTRICT HOSPITAL.

WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, expressly authorizes the City Mayor to represent the city in all its business transactions and sign in its behalf, all contracts and obligations, among others, upon the authority of the Sangguniang Panlungsod;

WHEREAS, Purchase Requests from the Hospital Director of Novaliches District Hospital amounting to Twenty Six Million Six Hundred Sixty Four Thousand Four Hundred Fifty Two Pesos and Fifty Centavos (\$\mathbb{P}\$26,664,452.50) for the provision of medical, dental and laboratory supplies to the Novaliches District Hospital were granted;

WHEREAS, on 25 February 2015, a memorandum was issued by the City Mayor directing all heads of departments, offices and operating units to observe the requirement that all purchase requests (PR) with an approved budget for the contract (ABC) amounting to P 10 million and above must be accompanied by a resolution duly adopted by the City Council authorizing the Chief Executive to enter into such contract;

WHEREAS, pursuant to existing laws, rules and regulations, and in compliance with the 25 February 2015 Memorandum from the City Mayor requiring an authorization from the City Council for PRs with an ABC of P10 Million and above, this resolution is hereby made for the said purpose.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does herby authorize, the City Mayor, Honorable Herbert M. Bautista, to enter into a contract or agreement with the winning supplier/bidder for the purchase of medical, dental and laboratory supplies amounting to Twenty Six Million Six Hundred Sixty Four Thousand Four Hundred Fifty Two Pesos and Fifty Centavos (\$\mathbb{P}26,664,452.50)\$, to be distributed to or used by, the Novaliches District Hospital
