RESOLUTION NO. SP- 6486 , S-2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ACQUIRE THROUGH NEGOTIATED SALE FOUR (4) ADJOINING PARCELS OF LAND IDENTIFIED AS LOTS 113, 114, 116 AND 117, ALL OF FLS-2592-D, SITUATED AT INTERIOR VILLAFLOR STREET, BARANGAY GULOD, NOVALICHES, QUEZON CITY, COVERED BY TRANSFER CERTIFICATES OF TITLE (TCT) NOS. 46403, N-201347, N-208494 AND N-288304, RESPECTIVELY, REGISTERED UNDER THE NAME OF BRENDA S. ANTONINO, CONTAINING A GROSS AREA OF TWO THOUSAND TWO HUNDRED THIRTY NINE (2.239) SQUARE METERS, MORE OR LESS, INTENDED FOR THE IMPLEMENTATION OF SOCIALIZED HOUSING PROJECT FOR THE BENEFIT OF INFORMAL SETTLER FAMILIES (ISFs) IN QUEZON CITY.

WHEREAS, the Quezon City Government (LGU-QC), through its Task Force on Socialized Housing and Development of Blighted Areas (TF Housing), in its desire to provide greater opportunities to significant number of Quezon City informal settlers/residents to own in-city affordable and decent housing, has been relentless in its efforts to expand its socialized housing projects;

WHEREAS, Ms. Brenda S. Antonino, registered owner of four (4) adjoining parcels of land situated at Interior Villaflor Street, Barangay Gulod. Novaliches, Quezon City, has expressed willingness to sell her properties at a negotiated price, which properties are identified as Lots 113, 114, 116 and 117, all of Fls-2592-d, covered by Transfer Certificates of Title (TCT) Nos. 46403, N-201347, N-208494 and N-288304, respectively, containing a gross area of Two Thousand Two Hundred Thirty Nine (2,239) square meters, more or less;

WHEREAS, the above-cited properties are vacant and considered suitable for socialized housing development;

WHEREAS, pursuant to Section 455 (b) (l) of Republic Act No 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Herbert M. Bautista, to acquire through negotiated sale four (4) adjoining parcels of land identified as Lots 113, 114, 116 and 117, all of Fls-2592-D, situated at Interior Villaflor Street, Barangay Gulod, Novaliches, Quezon City, covered by Transfer Certificates of Title (TCT) Nos. 46403, N-201347, N-208494 and N-288304, respectively, registered under the name of Brenda S. Antonino, containing a gross area of Two Thousand Two Hundred Thirty Nine (2,239) square meters, more or less, intended for the implementation of socialized housing project for the benefit of informal settler families (ISFs) in Quezon City.
