RESOLUTION NO. SP- 6492 S-2015

A RESOLUTION AMENDING RESOLUTION NO. SP-6170, SERIES OF 2014, "A RESOLUTION AUTHORIZING THE PURCHASE BY THE QUEZON CITY GOVERNMENT THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, OF TWO (2) UNITS OF MOTOR VEHICLES AMOUNTING TO ONE MILLION SIX HUNDRED THOUSAND PESOS (P1,600,000.00), TO BE CHARGED AGAINST THE FUNDS OF THE OFFICE OF COUNCILOR MARIVIC CO-PILAR, INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS UNDER HER OFFICE", ADJUSTING AND INCREASING THE AMOUNT OF ONE MILLION SIX HUNDRED THOUSAND PESOS TO TWO MILLION ONE HUNDRED THOUSAND PESOS (P2,100,000.00).
