RESOLUTION NO. SP- **6499**, S-2015

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE IN THE AMOUNT OF ONE MILLION, THIRTY FIVE THOUSAND SEVEN HUNDRED SIXTY PESOS (PHP1,035,760.00), TO BE USED AS AMBULANCE FOR DISTRICT V, INITIATED BY THE OFFICE OF COUNCILOR JULIENNE ALYSON RAE V. MEDALLA, CHARGEABLE AGAINST THE AVAILABLE FUNDS OF THE SAME OFFICE.

WHEREAS, the Office of Councilor Julianne Alyson Rae V. Medalla has requested for the purchase of one (1) unit of motor vehicle, with the following specifications;

WHEREAS, the aforementioned motor vehicle will be used by the same office as an ambulance for District V in order to save lives in critical condition;

WHEREAS, Section 455 (b) (1) (vi) of Republic Act. No. 7160, otherwise known as the "Local Government Code of 1991", provides that the City Mayor shall represent the City in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to purchase one (1) unit of Motor Vehicle in the amount of One Million Thirty Five Thousand Seven Hundred Sixty Pesos (Php1,035,760.00), to be used as ambulance for District V, a program initiated by the Office of Councilor Juliennne Alyson Rae V. Medalla, chargeable against the available funds of the same office.
