A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE HONORABLE MAYOR HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF THREE MILLION PESOS (PHPS,000,000.00) TO THE "CULTURTAIN MUSICAT PRODUCTIONS, INC.", SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, Culturtain Musical Productions, Inc. (Culturtain, for brevity), a domestic company registered under the laws of the Philippines, was formed by singer-actress Celeste Legaspi and talent manager Girlie Rodis. It traces its roots to Musical Theater Philippines, Inc. (Musical), and its goal is to produce original Filipino musicals:

WHEREAS, Culturtain is embarking on its biggest project, "Ang LARAWAN. the Movie Musical", which is currently in the production phase. It is a film adaptation of the stage musical based on the National Artist Nick Joaquin's "Portrait of the Artist as Filipino" translated and directed by National Artist Rolando S. Timo with music by Ryan Cayabyab initially presented in 1997 at the Cultural Center of the Philippines. It is a valuable addition to artistic works celebrating Philippine excellence to achieve a deeper appreciation of our rich and valuable heritage through the arts;

WHEREAS, in support of the aforementioned project, the Quezon City Government, through the Honorable Mayor Herbert M. Bautista, has pledged to award a financial grant in the amount of Three Million Pesos (Php3,000,000.00) to Culturtain Musical Productions, Inc., payable in full;

WHEREAS, in exchange for the invaluable support of the Quezon City Government, Culturtain Musicat Productions, Inc. shall:

- I. Provide a copy of the video footage of the "LA NAVAI. PROCESSION", where the image of our Lady of La Naval, a 16<sup>th</sup> Century Ivory and wood statue enshrined at the Santo Domingo Church in Quezon City was used during the procession scene of the movie;
- Allow the display of some of the costumes used in the movie at the Quezon City Museum;
- Properly acknowledge the Quezon City Government in their support of Culturiain's movie project in all releases and social media;
- 4. Include the Quezon City Film Development Commission in the closing credits of the movie; and
- Provide special screening of the movie for the Quezon City Government officials and employees on a mutually agreed date and time.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, through the Honorable Mayor Herbert M. Bautista, to grant financial assistance in the amount of Three Million Pesos (Php3,000,000.00) to the Culturtain Musical Productions, Inc., subject to existing laws, rules and regulations.
