RESOLUTION NO. SP- **6508** , S-2015

A RESOLUTION ALLOCATING THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (PHP150,000.00) AS FINANCIAL ASSISTANCE TO ATTY. ELIZABETH PAGDILAO, WHO RETIRED AS 2ND ASSISTANT CITY PROSECUTOR OF QUEZON CITY, TO BE TAKEN FROM THE APPROPRIATION OF THE OFFICE OF THE CITY MAYOR UNDER GRANTS, SUBSIDIES, AND CONTRIBUTIONS IN THE ANNUAL BUDGET FOR FISCAL YEAR 2015.

WHEREAS, Section 458 (a) (1) (xi) of Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", provides that "When the finances of the city government allow, provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers, and other national government officials stationed in or assigned to the City";

WHEREAS, retired Assistant City Prosecutor Elizabeth Pagdilao finished her elementary studies at Kamuning Elementary School in Quezon City and Secondary schooling at Quezon City High School in year 1960 and 1964, respectively;

WHEREAS, after passing the Bar examination in 1976, she worked as a Revenue Legal Officer I at the Bureau of Internal Revenue until 15 October 1997 as Attorney III. On 16 October 1997, Atty. Pagdilao was appointed by the Department of Justice and assumed office as a Prosecutor and was assigned in Quezon City;


WHEREAS, Prosecutor Pagdilao, faithfully served Quezon City since 16 October 1997 until her retirement last 20 June 2014. She retired as 2nd Assistant City Prosecutor (ACP) of Quezon City;

WHEREAS, the unwavering public service of retired ACP Elizabeth Pagdilao to the people of Quezon City, through legal services rendered, deserves recognition and appreciation from the Quezon City Government. In recognition for her dedicated and outstanding services of almost Seventeen (17) years to the constituents of Quezon City, it is just and proper to extend grant her financial assistance in order for her to enjoy fully her retirement from Public Service.


NOW, THEREFORE,
