A RESOLUTION REQUESTING THE HONORABLE MAYOR HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE TO ATTY. ZENAIDA A. ABAD, WHO RETIRED AS 2ND ASSISTANT CITY PROSECUTOR OF QUEZON CITY EFFECTIVE JULY 13, 2014, IN THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00), SUCH AMOUNT TO BE TAKEN FROM THE APPROPRIATIONS OF THE OFFICE OF THE CITY MAYOR UNDER GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE CITY'S ANNUAL BUDGET FOR CALENDAR YEAR 2016.

WHEREAS, 2nd Assistant City Prosecutor Zenaida A. Abad, retired compulsorily, having reached the age of sixty five (65) on July 13, 2014;

WHEREAS, she has rendered a total of almost eighteen (18) years of continuous, dedicated, efficient and competent service as Assistant City Prosecutor;

WHEREAS, prior to her appointment as Assistant City Prosecutor, she was an employee of the Bureau of Internal Revenue from year 1981, 1984-1989, 1992 and 1994-1995;

WHEREAS, consistent with the policy of this august body, a financial assistance to dedicated, loyal and deserving Prosecutors of the City, in the amount of One Hundred Fifty Thousand Pesos (P150,000.00) may be set aside by the city government for the said purpose.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby request the Honorable Mayor Herbert M. Bautista, to grant financial assistance to Atty. Zenaida A. Abad, who retired as 2nd Assistant City Prosecutor of Quezon City effective July 13, 2014, in the amount of One Hundred Fifty Thousand Pesos (Php150,000.00), such amount to be taken from the appropriations of the Office of the City Mayor under Grants, Subsidies and Contributions in the City's Annual Budget for Calendar Year 2016.
